About the MSC



The Missouri Safety Center (MSC) at the University of Central Missouri has been in operation since 1967 and provides education, research, and training to a multitude of audiences. The Missouri Safety Center is a Licensed Provider Organization for Continuing Education for the Missouri Department of Public Safety Peace Officer Standards and Training (POST) Program.

Our instructors come from diverse backgrounds including active and retired law enforcement, subject matter experts in an array of fields of study and practice, ACTAR board members, Law Enforcement Traffic Safety Advisory Council (LETSAC) Board members, transportation and traffic professionals, tactical experts, researchers, and individuals serving the public safety and law enforcement community for years.

The Missouri Safety Center operates through grant activities involving a number of traffic safety related areas including statewide surveys for occupant protection, enforcement grant activities, impaired driving countermeasures for alcohol and drugs, and driver improvement programs.

The Missouri Safety Center also houses the Missouri Motorcycle Safety Program with statewide oversight of basic and advanced rider courses, as well as 3Wheel courses.

Continuing education training is essential to maintain the safety of our communities and the safety of those professionals performing public safety functions. We are committed to education, training, research, public service, and publications to work towards injury and death prevention in the state of Missouri and throughout the nation.



State IID Coordinator

- Oversees and inspects install location throughout the state.
- Works with MoDOT Highway Safety on implementation and revision of current CSR and state statute.
- Conducts manufacturer inspection on current and future IIDs approved in the state of Missouri.
- Works with DOR/ Licensing & General Council insuring compliance as set through CSR and state statute.



IID Training

- Provides IID training to law enforcement in conjunction with MSC & MSHP Type II Supervisor Classes
- Provides IID training when requested by Missouri law enforcement agencies.
- Provides training and expert testimony for law enforcement, attorneys, and Judges.





Manufacturers & Devices

Currently there are **five** approved IID manufactures and **seven** different IID devices approved for use in Missouri. At the present time there are approximately 10,000 drivers required to install and maintain an IID on any vehicle that they operate (FY2020). This number fluctuates from month to month because of drivers being ordered by the courts or the Missouri Department of Revenue (DOR) to install the devices and complete the program.
