About the MSC



The Missouri Safety Center (MSC) at the University of Central Missouri has been in operation since 1967 and provides education, research, and training to a multitude of audiences. The Missouri Safety Center is a Licensed Provider Organization for Continuing Education for the Missouri Department of Public Safety Peace Officer Standards and Training (POST) Program.

Our instructors come from diverse backgrounds including active and retired law enforcement, subject matter experts in an array of fields of study and practice, ACTAR board members, Law Enforcement Traffic Safety Advisory Council (LETSAC) Board members, transportation and traffic professionals, tactical experts, researchers, and individuals serving the public safety and law enforcement community for years.

The Missouri Safety Center operates through grant activities involving a number of traffic safety related areas including statewide surveys for occupant protection, enforcement grant activities, impaired driving countermeasures for alcohol and drugs, and driver improvement programs. The Missouri Safety Center also houses the Missouri Motorcycle Safety Program with statewide oversight of basic and advanced rider courses.

Continuing education training is essential to maintain the safety of our communities and the safety of those professionals performing public safety functions. We are committed to education, training, research, public service, and publications to work towards injury and death prevention in the state of Missouri and throughout the nation.

TYPE III OPERATOR

This course includes 2 sections (*with options for a third):

Type III Operator:

MO DHSS 4 hour breath-Alcohol Training Course. (Hours: 3 Technical, 1 Legal)

Instrument Labs:

MO DHSS 4 hour Breath-Alcohol Instrument Course. (Hours: 2 Technical, 2 Skill)

NOTE: SFST 24-Hour Basic, 8-Hour Refresher, and 4-Hour Refresher courses can be added to a Type III operator class at the request of the host agency.

You may be trained on a maximum of two instruments during this course. Applicants **MUST** indicate which instrument(s) during the registration process.

POST credit is available (without cost) and tuition is waived for all full-time Missouri law enforcement officers.

The Type III Operator Course is delivered through the Missouri Safety Center located at 1200 South Holden Street, Warrensburg, MO. In addition to courses held at the Center, we offer the option to conduct on-site training for law enforcement agencies upon request to support regional access and operational readiness.

Any student registering to attend one of our REGIONAL Type III Operator Courses will find the address of the training site on the registration site.



TYPE III OPERATOR LABS

The Instrument Lab of the Type III Operator class contains a four hour block of instrument specific training.

This course accompanies the Type III Operator training course. In order to become a Type III permit holder, law enforcement officers must attend both the Type III Operator Course AND at least one Type III Instrument Lab. The lab may be attended for refresher training (or permit renewal); however permission from the breath alcohol program manager must be obtained prior to registration.

This course may also be taken when a current Type III permit holder is adding or changing the instrument(s) listed on their Type III permit.

Who may attend?

Those seeking a Type III permit for the breath alcohol instrument used at their department or surrounding agencies, which is approved for evidential breath alcohol testing in the State of Missouri.

Type III labs available:

- Alco Sensor- IV w/ Printer
- Intox DMT
- Intox EC/IR II
- Intoxilyzer 8000



TYPE II SUPERVISOR

- You must be a P.O.S.T. certified law enforcement officer with a minimum of two years of service as a law enforcement officer OR be a full time employee of a jail or detention facility.
- You must possess a valid Type III permit.
- You must have maintained a valid permit for no less than one year for the instrument for which you want to be a Type II Supervisor.
- Your Department owns one or more breath alcohol instruments or is in the process of obtaining one from the Breath Alcohol Program.
- Your Department currently has less than two, Type II Supervisors.





TYPE II SUPERVISOR LABS

Part two of the Type II Supervisor process (8 hour lab) is scheduled once you are confirmed for enrollment in Part One (36 Hrs). Notification of the specific dates for Part Two (8 hours) will be established in the second step of the enrollment confirmation process.

When you register for the Type II Supervisor Course REMEMBER to check the appropriate instrument(s) you require training on.

Note: We are no longer conducting training on the Intoxilyzer 5000 or the BAC Datamaster. We can only train on the following instruments:

- Alco Sensor 4 w/Printer
- Intox DMT
- Intox ECIR2
- Intoxilyzer 8000

All courses are conducted in Warrensburg, MO at the Missouri Safety Center, 1200 South Holden, unless otherwise indicated.

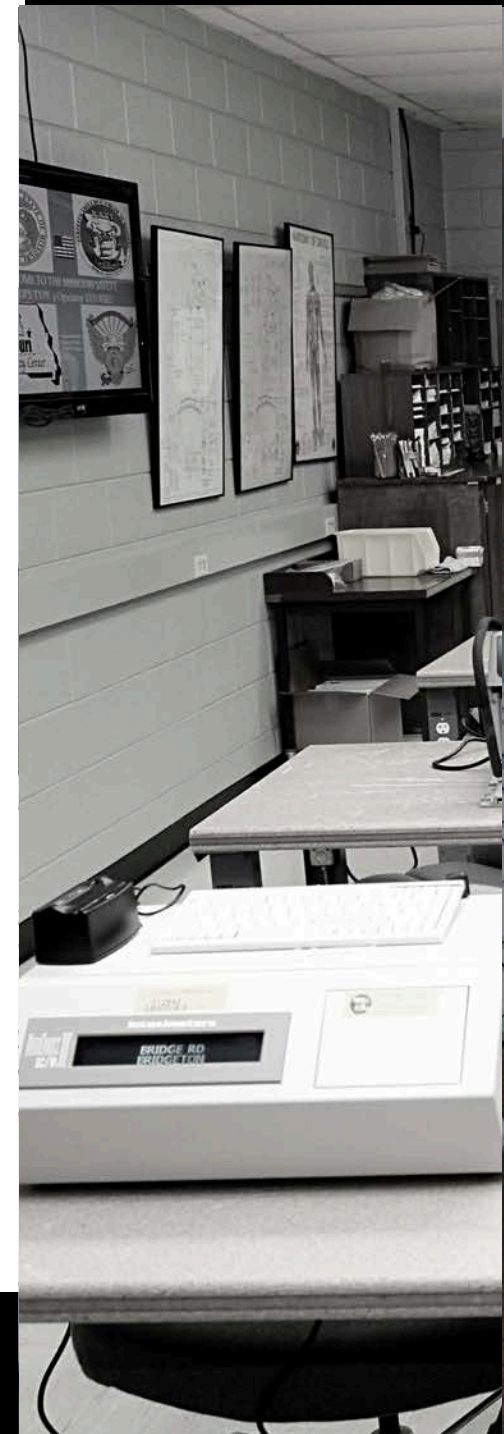
P.O.S.T. credit is available for all full-time Missouri law enforcement officers. Tuition is waived for Missouri officers.
